Historic Clifton

“Names, Places and People – Oh, my!!”

*Lynne Garvey-Hodge, Chairperson, The Fairfax County History Commission ***

From familiar names yet today to school plays, from stolen automobile parts to a chicken coop thief, from kitchen burns to teenage delinquency, to a drowned Titanic Acacia Masonic Lodge #16 member – life in **Clifton**, Virginia always seemed and seems to hold more than just a wee bit of drama and intrigue! Included in this month’s “Clifton Clatter” newsletter’s history column, are two short columns from April, 1927 – that then cap out around June 20, 1949. While we no longer enjoy a weekly publication of the *Fairfax Herald*, the stories, information and names therein over time, give us an idea of what daily Clifton life was like in days gone by.

Included here are two adjoining columns from the April 29, 1927 *Fairfax Herald*; The “Clifton” column and the “Centreville” column carry names and stories that mirror one another. And a very short *Fairfax Herald* spot from the 1920’s brings to life a man and his son - who both struggled with walking a straight line – for much of their life. Like many others, intoxication led down a path of not just self-destruction, but destruction of his own personal reputation. Her is a finale reference, in re: Perry Lee Compton, Jr. v. Commonwealth of Virginia – see the June 20, 1949 Writ of Error file:///C:/Users/Owner/Downloads/190VA48_3589_Petition_for_Writ_of_Error.pdf. Particularly for those of you who practice law - you will find the read of this somewhat tedious Writ of Error, entertaining, eye rolling, and in the end a bit of a victory for Mr. Compton via the use of the word “adjoining”. We can find relief in that Mr. Compton apparently has a home and a family to return to – and will likely celebrate his somewhat limited legal victory with perhaps an adult beverage, or two.

Mr. Louis Ensor was in the village over the week-end furnishing an apartment in his house for occupancy when he comes here.

Mrs. Trevasco spent the week-end in Philadelphia.

Miss Katherine Doak spent the week-end in Washington.

Rev. T.H. MacLeod will preach in the Presbyterian church next Sunday. After that the student from Princeton who preached Easter Sunday will conduct services in the summer months.

Mrs. Harding is ill at her home in the village.

The senior play, “A Perfect Goose” will be given Friday night in the school auditorium.

Mr. and Mrs. Thomas Mock, Jr., and family have moved to the house recently vacated by Mr. and Mrs. Ambler [author’s note: this would most likely have been the current location of “Belle Jar”], and Mr. and Mrs. Herbert Weaver have moved to their own place.

Mr. and Mrs. John Wells and children were week-end visitors at the home of Mrs. John Curtis, Mrs. Wells’ mother.

Miss Mary Lippard gave her 4-H girls instructions in their work Monday in the school building. [author’s note: this would be the original Clifton School c. 1912 atop the hill where the now-closed Clifton Elementary School stands]

Mrs. Tom Buckley scalded her hands very seriously one day last week. Dr. Joseph Sanford rendered first aid and after that she went to Ivakota to have the burns dressed.”

[author’s note: Ivakota was once a National Florence Crittenden Home for for un-wed mothers. It was located at the intersection of Compton Rd. and (currently) Balmoral Greens Ave. There is a Fairfax County History Commission marker at the intersection now. Careful inspection of nearby properties will reveal “entrance” gates that would have served the 200+ acre farm/school and nursing facility. It is noteworthy that the home provided schooling for the young women – especially in the areas of nursing, gardening, animal husbandry, home-making and sewing/weaving. With Mrs. Buckley’s visit to Ivakota for medical purposes we can discern that the quality of medical care associated with the facility was of the highest quality. Additionally, the Compton Rd. school built for the home c. 1925, was eventually renovated into the home of Clifton’s Boyd family, c.1963.]

“Centreville”

“The play ‘Poor Married Man’ was successfully produced Thursday afternoon of this week, in the school auditorium, by the Junior League. The attendance was good and the money made will be used in paying for chairs recently purchased by the school league.

Horses owned by Mr. Bernard Buckley and Mr. Gentry were killed by lightning during the thunderstorms of last week, while in the fields.

Mrs. George Tuberville, who has been ill for several months is reported much better and Mr. Tuberville who was also on the sick list, is recovering.

Mr. and Mrs. Delbert Robertson, are the happy parents of a baby daughter, born a few days ago.

The school bus operating between Centreville and Clifton is now being driven by Mr. Lawrence Buckley instead of Mr. Croson.

Miss Ada Ambler, April 22 was married to Mr. Meredith Fullerton and Sunday, April 24 they were Clifton visitors. Mr. and Mrs. Fullerton will stay at the home of the parents of the bride, for a short time, while their home is being made ready.

The Centreville Junior League has purchased equipment for baseball, basketball and croquet and will fit out the school grounds. The Senior League has purchased two maps for the school and the primary grades are making bird boxes to go in the trees on the school grounds.

Mrs. Brock and daughter are at their summer home near Clifton.

The April meeting of the School League was well attended and the program enjoyed. Mrs. Buckley sang; the Junior League entertained and refreshments were served.”

*[Author’s note: the Mrs. Buckley noted here was likely the songstress and pianist, Helen Buckley who came to live in the home once occupied by the Acacia Masonic Lodge #16’s infamous and handsome Oscar Scott Woody, a U.S. postal clerk who lost his life on the **Titanic**, on his 44th birthday as the clock stroked midnight – the night of that fatal April 14, 1912 disaster]*

“Sent to Reform School”

[from the *Fairfax Herald* – 1920’s; exact date unknown]

“About ten days ago the automobile of Josh Buckley of Clifton, was stolen in Clifton and when found later a number of parts were missing from it. A boy, Perry Compton Jr., was arrested on a charge of being implicated in the theft. As he was under 18 years of age, the case was referred to the Juvenile Court, Judge Ritchie, and the boy was found guilty. He was sentenced to the state reform school until 21 years of age and will be taken there in a day or two.”

* * * * *

Sadly, Mr. Compton, Jr. struggled with sound decision making and “adulthood” behaviors. It takes an unusual twist of thinking/inebriation to enter into a chicken coop at midnight and steal four (4) of forty-four chickens – worth approximately \$5.00 from the property of another. (see the link above) The victim was a Kirby Day whose farm in Annandale, Virginia was so burglarized.

**** The author has taken the liberty of revealing various pieces of Clifton history in the sharing of these stories. The Perry Compton family clearly had a presence in our land – hence the name of Compton Rd. nearby.**

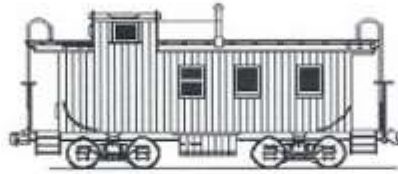

A RESOLUTION: RENAMING THE PLAYGROUND PARK TO “HARRIET AND WILLIAM HARRIS PARK”

WHEREAS, the Clifton Historic Preservation Committee has long been interested in commemorating in some way the legacy of the African American Harris family in the Town of Clifton; and

WHEREAS, historically, one William E. Beckwith in the 1800s resided on a 1200 acre plantation, on the land where Clifton would be founded, with an African American slave partner named Sophie Ellzey, and between them they had a family consisting of seven children; and

WHEREAS, one of those children was a daughter named Harriet Ellzey, born to Sophie Ellzey about 1827; and

WHEREAS, Harriet Ellzey, slave of William and daughter of Sophie, went on to “marry” and begin a family with William Harris sometime in the late 1840s; and

WHEREAS, upon the death of William E. Beckwith in 1863, Harriet Ellzey Harris and her children inherited land from William’s estate adjacent to property where Harrison G. Otis was establishing a railroad station, hotel and post office that would be named Clifton Station; and

WHEREAS, Harriet and William Harris built a house on their land and were living there with their children sometime around 1868, thus being the first family to reside in the newly forming village; and

WHEREAS, Harriet and William significantly contributed to the formation of the town of Clifton by subdividing some of their property and selling lots, and by providing land for and helping to establish the Primitive Baptist Church, which still stands today, and which also served as the first schoolhouse for the African American children of the neighborhood;

WHEREAS, there is currently a movement to recognize the efforts and contributions of ex-slaves and African Americans to society, exemplified in Clifton by the actions of Harriet and William Harris; and

WHEREAS, numerous community groups including homeowners surrounding the playground park, homeowners on Chapel Street (which was previously known as Harris Street), the newly-formed Racial Justice Committee, and many others advocated for and supported renaming the park to Harriet and William Harris Park;

NOW THEREFORE, Be it resolved by the Town Council of the Town of Clifton that the Town of Clifton's playground park shall henceforth be known as Harriet and William Harris Park.

Resource Recovery Tip

You probably know that most big retailers will take back plastic bags. But did you know that they also take dry cleaning bags, bread bags, Ziplock type bags, bubble wrap, ice bags, and more? The recovered plastic film is reprocessed into new bags, pallets, containers, crates, pipe, and composite lumber for making decks, benches, and playground sets.

Some items that are not included are compostable bags, pre-washed salad mix bags, frozen food bags, candy bar wrappers, chip bags, and cut flower sleeves.

Some tips on how to tell if an item is plastic film.

Is there a #2 or #4 in a chasing arrows recycling symbol on the item?

Does the item hold its shape when it is crumpled?

Does it stretch instead of tearing like paper?

If you answer yes to one or more of these questions, then the resource can be recovered.

Resource recovery is more than recycling. It is finding the highest and best use for items including reuse, repurpose, rehome, and recycle.
